2025 Fall Outlook

With so many issues at stake and an unprecedented amount of political noise, the KDCR Partners team is here to help you cut through the commotion and track the key issues shaping the policy agenda this fall and beyond.

Key Stats from the 119th Congress

- 38 of the bills passed in the 119th Congress have been [signed](#) into law, including 16 Congressional Review Acts (CRAs) overturning Biden-era federal rules.
- For the first time since 2018, the Senate passed three FY26 appropriations bills before August recess—Military Construction-Veterans Affairs, Agriculture-FDA, and Legislative Branch. The House passed two FY26 appropriations bills—Defense and Military Construction-Veterans Affairs.

Congress Agenda

- Congress returned on November 12, 2025, after the longest government shutdown in U.S. history
- House and Senate leadership and appropriators are working on a path forward for the January 30, 2026, government funding deadline.
- Senate Majority Leader John Thune (R-SD) committed to a Senate vote on ACA subsidies sometime in December 2025.
- Other possible priorities:
 - Disaster supplemental appropriations
 - [Extenders](#)
 - Reforms to the confirmation process to prioritize [confirming](#) more than 140 outstanding Trump nominees, including more than 30 ambassadors.

Trump Admin

- Continued focus on implementation of the One Big Beautiful Bill Act (OBBBA) (Public Law 119-21) and various [executive orders](#).
- Ongoing negotiations with trading partners.

- Release of the MAHA Commission's strategy document
- Release of the 2025–2030 Dietary Guidelines for Americans
- Farm Bill extension
- Implementation of SNAP provisions from OBBBA

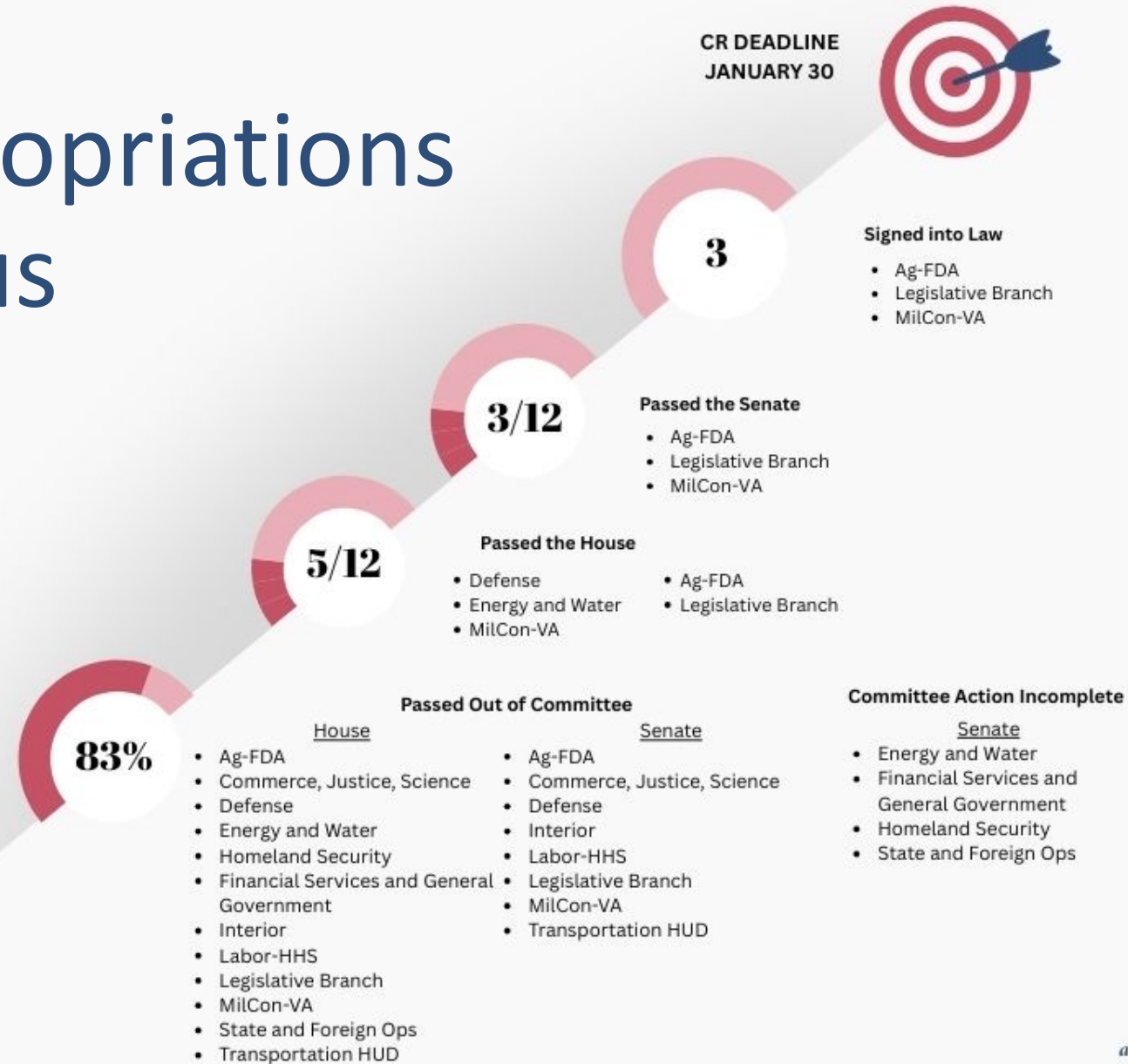

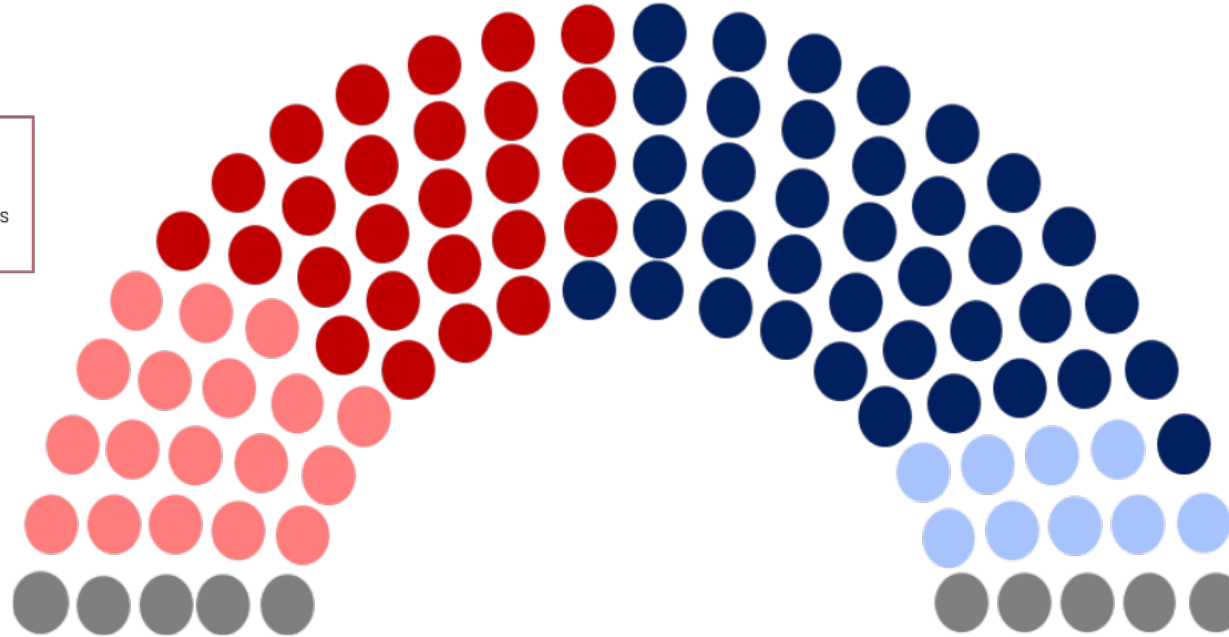

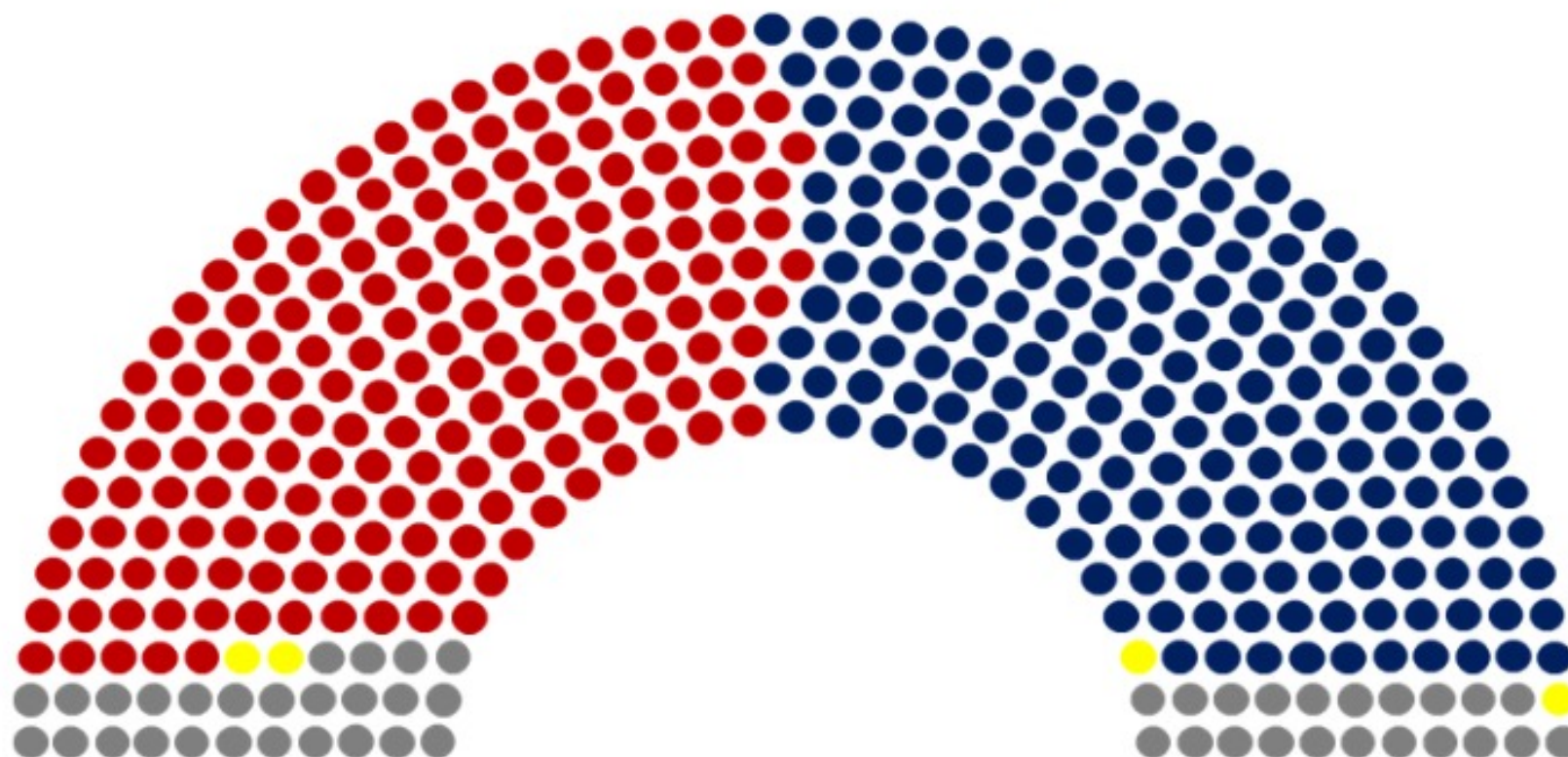

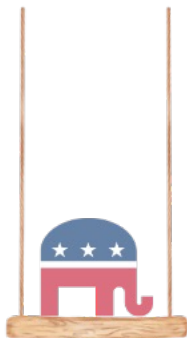

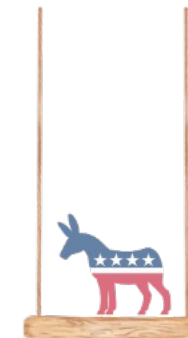

6% of House Democrats are running in districts Trump won in 2024.

Only two contested seats held by Senate Democrats are in states Trump won in 2024—Georgia and Michigan.
